**RE:** Sponsorship for The Mission Project's 2018 Derby Gala fundraising event.

**RECOMMENDATION:** Approve the Grandstand Sponsorship in the amount of \$1,500 for The Mission Project's 2018 Derby Gala fundraising event.

**DETAILS:** The Mission Project is a not-for-profit organization dedicated to enabling adults with developmental disabilities, such as Down syndrome and autism, to live and work on their own with individualized support. The Mission Project provides supports and programs to help participants live safe and meaningful lives, and to connect socially. Services include:

- Transportation to work and activities
- Weekly social skills group
- Instruction in daily living skills
- MPower Health, a program that helps them remain active and fit
- Programs to promote healthy eating
- Organized social and leisure activities
- Technology training (every participant has an iPad)
- Travel opportunities
- 24-hour Help Line

Mission Project participants enjoy living in their own apartments and socializing in their own community while being supported by parents, other family members, friends and dedicated professionals. The Mission Project is situated in Mission, Kansas, a safe community that has jobs, services, entertainment and a community center within walking distance of apartments.

The City has historically supported The Mission Project in a variety of ways whether through programs and services at the Community Center or by building relationships with the Police Department. They provide a unique and invaluable service and benefit to our community.

At the March 7 Finance & Administration Committee meeting, Councilmember Pat Quinn presented information on The Mission Project's annual fundraiser and asked the City to consider a Grandstand Sponsorship in the amount of \$1,500 for the May 5, 2018 Derby Gala event.

Funds for the sponsorship would be allocated from the Council's "Public Relations" line item in the 2018 Budget. Available funding is \$6,000.



### PURPOSE

The Mission Project enables capable adults with developmental disabilities to live independently and safely in community with individualized support.

### GOALS

Mission Project participants live full lives in a supportive community. They have numerous opportunities for growth and development, including:

- Finding and maintaining meaningful employment
- · Socializing with peers
- · Learning new skills in a variety of classes, including acting, karate and computer use
- Participating in recreational and cultural activities
- Getting and staying fit and developing healthy, safe lifestyles
- Developing leadership skills and giving back to their community
- Honing social skills and resolving interpersonal challenges

### WHO'S INVOLVED

Parents, guardians, families and friends of adults with developmental and cognitive disabilities, as well as dedicated professionals, have joined forces to realize the goals of the project.

### WHY MISSION, KANSAS?

The Mission Project, Inc. is based in Mission, Kansas, because it's a well-run community that has jobs, services, entertainment and a community center within walking distance of apartment complexes, decreasing participants' need for transportation.

### **PROJECT HIGHLIGHTS**

- The first participant moved into her apartment in Mission in summer 2004. As of winter 2018, the project has 20 participants. In 2012 we were excited to expand by welcoming Mission Project 2, which now has 11 participants.
- Families can hire an employment specialist from a licensed agency, who develops jobs and provides job training and ongoing counseling for participants.
- Families can contract with licensed independent living skills providers who offer training and support for their participants.
- Volunteers answer a 24-hour Help Line to provide support and respond to emergencies.
- Frequent social activities promote friendship and build community.
- Drivers provide transportation to and from work, using vans acquired by the Mission Project.
- MPower Health wellness program promotes healthy lifestyles, which include daily exercise and nutritious eating.

### FUNDING

The Mission Project, Inc., a 501(c) (3) not-for-profit corporation, has two major fundraisers each year, a Kentucky Derby Gala and a golf tournament in the fall. Proceeds from these and future events will go toward transportation and programming costs. The Mission Project also receives funding from grants. The Mission Project's Federal Tax ID #83-0393426.

### GOVERNANCE

The Mission Project, Inc. is led by a board of directors, who work with a steering committee comprising parents and guardians of participants. Board officers: Ed Soltz, President; Bob Randall, Secretary; Doug Niedens, Treasurer.

**RE:** Resolution Authorizing Certain Signatories for the City of Mission's Checking Accounts

**RECOMMENDATION:** Approve the resolution Authorizing Certain Signatories for the City of Mission's Checking Accounts.

**DETAILS:** The City of Mission conducts all of its banking activity with Security Bank of Kansas City (formerly d/b/a Mission Bank). The City has four separate checking accounts with Security Bank:

### Checking Account: XXXX-XXXX-6933

A general checking account from which all payables for items purchased, services received, debt paid, and all personnel costs are made.

### Court Bond Reconciliation Account: XXXX-XXXX-6950

A checking account that serves as a clearing account for municipal court bonds that are received and then repaid when cases are adjudicated.

### Conduit (Employer 125) Account: XXXX-XXXX-1836

A checking account that serves as a clearing account for payroll deductions that are received and paid out for the employee flexible spending account.

### Mission Farm and Flower Market Account: XXXX-XXXX-6694

A checking account that serves as a clearing account for receipts and payables associated with the Supplemental Nutrition Assistance Program (SNAP) that is supported by the Mission Farm and Flower Market.

The Mayor, City Treasurer and Finance Director have traditionally been the signatories on the Checking Account. Court clerk staff are the signatories on the Court Bond Account Reconciliation Account. The Finance Director is the signatory on the conduit account, and the Market Coordinators and Finance Director on the Market Account.

With the recent election of a new Mayor, the retirement of the City Treasurer, and changes in municipal court personnel there is a need to update the signatories on the corresponding accounts. The attached resolution will express the City's desire to formally authorize new signatories on the appropriate checking accounts with Security Bank of Kansas City. Previously, the bank did not require formal Council action to update these records.
