MAY 24, 2017

The Mission City Council met for a Special City Council Meeting at Mission City Hall on Wednesday, May 24, 2017 at 6:00 p.m.. The meeting was called to order by Mayor Steve Schowengerdt. The following councilmembers were present: Ron Appeltoft, Tom Geraghty, Suzie Gibbs, Kristin Inman, Debbie Kring, Pat Quinn, Arcie Rothrock, Nick Schlossmacher.

Ms. Smith stated that there are two resolutions for consideration this evening for TIF Redevelopment Project Plans. The first relates to the EPC development, Mission Trails. State law requires that the City Council pass a resolution officially calling a public hearing to consider the Redevelopment Project Plan. This resolution must be passed not less than 30 days and not more than 70 days prior to the date of the hearing. This resolution sets the public hearing date for 7:00 p.m. at the July 19th City Council meeting and it is anticipated that Council will also consider the Redevelopment Plan and Development Agreement at this meeting. She stated that if Council does not feel ready to adopt the Redevelopment Plan and Development Agreement on that date, we can always have a separate meeting to consider them. She stated that this time frame will also be the same for the Gateway Third Amended Redevelopment Plan to be considered next on this agenda. The Planning Commission has found both plans in Ms. Smith stressed that Council may have as many meetings as necessary, and they will not be rushed in their decisions on these developments. She again stressed that the resolutions to be considered tonight only set the public hearings and do not commit Council to any incentives.

Councilmember Quinn asked if there will be public meetings on these development projects. Ms. Smith stated that these will be discussed during a worksession and at the July committee meetings, all of which are open to the public. She also asked if any councilmember has a vacation scheduled to please let her know as meetings are being scheduled.
