

Action items require a vote to recommend the item to the full City Council for further action.

**RE:** Mission Parks and Recreation Facilities Reopening Plan and Operational Controls

**RECOMMENDATION:** Review and approve a reopening plan for Parks & Recreation facilities including the Community Center.

**DETAILS:** Following approval of Resolution 1049 on May 13, 2020 which outlined the City's general reopening and recovery plan for City facilities, programs and services, staff committed to preparing and recommending a more specific plan for parks and recreation and municipal court.

The focus of the May 27, 2020 Special City Council meeting will be on parks and recreation facilities and programs as many of these are included in Phase II of the state-wide recovery plan that became effective May 22, 2020.

Included in the packet are two memorandum and matrices which detail the various recommendations and protocols to be implemented upon final Council approval. The list, particularly as it pertains to operation of the Community Center is comprehensive and was developed with input from staff (including full-time parks and recreation staff), survey of other metro communities with similar facilities, guidance provided by state resources, and reference to other professional organizations.

Consistent with other COVID-19 recommendations to date, this reopening and recovery plan lags behind the timelines allowed by the state. This is intentional and based on our belief that each phase and transition will require extensive planning, staff training, and patron communication and education in order to implement safely and effectively.

A member survey specific to the reopening of the Community Center was distributed on May 21, 2020 and results will be compiled and presented during the meeting. The survey was designed to gauge member's overall comfort with our facility's reopening as well as their feelings about reopening of other businesses and activities. The survey is intended to help provide insight into how we might anticipate our members' plans to come back.

**CFAA CONSIDERATIONS/IMPACTS:** The City seeks to establish policies and practices that ensure the delivery of essential services and programs while also taking steps to protect the health of our residents, businesses, visitors and employees in the midst of a public health crisis.

### BACKGROUND

As the City, County, and State move through reopening and recovery plans amidst the COVID-19 pandemic, much attention has been given to parks and recreation facilities. A thorough evaluation and analysis of Mission's ability to re-open the Community Center and other parks amenities has taken the following into consideration:

- Health and safety of patrons and guests
- Health and safety of staff
- Quality of the experience
- Financial impacts
- Perception of safety
- Staff ability to consistently implement safety/sanitizing procedures
- CDC guidelines
- Governor Kelly's Ad-Astra: A Plan to Reopen Kansas
- Industry guidelines and direction
- Neighboring communities' plans and recommendations

A careful and systematic approach to the potential impacts in each area of operations yielded the attached documents for your review and consideration:

- MISSION PARKS & RECREATION COVID-19 REOPENING PLAN
- COMMUNITY CENTER COVID-19 REOPENING PLAN

### MISSION PARKS & RECREATION COVID-19 REOPENING PLAN

This reopening plan matrix was constructed using the phases outlined in Governor Kelly's "Ad Astra: A Plan to Reopen Kansas" as a starting point. In addition, where appropriate, a more conservative approach to reopening and recovery has been recommended to align with the goals and objectives of our Governing Body.

The intent of this matrix is to communicate responsibility in safeguarding people. It contains detailed operational information for each park facility or amenity outside of the Powell Community Center, which is addressed in a separate matrix.

## **MEMORANDUM**

The specific recommendations for various facilities include:

- Handball Courts - reopen Phase 4/Phase Out
- Tennis Courts - never closed/remain open throughout
- Outdoor Pool (MFAC) - will not open for 2020 season
- Sprayground - opens Phase 3
- Playgrounds - reopen Phase 4/Phase Out
- Park Rentals - reopen Phase 4/Phase Out
- Park Restrooms - reopen Phase 4/Phase Out

Cleaning and sanitation protocols have been adopted and will be implemented at the Sprayground and park restrooms and playgrounds once they reopen. Social distancing will be emphasized at every location. Signage at parks, park facilities, kiosks and messages on social media channels will be consistent to eliminate confusion and create a strong central message of expected and appropriate behaviors.

Additional operating guidelines or actions are included in the matrix.

### **COMMUNITY CENTER COVID-19 REOPENING PLAN**

This reopening plan matrix was also constructed generally relying on the phases outlined in Governor Kelly's "Ad Astra: A Plan to Reopen Kansas." The intent of this matrix is to communicate responsibility in safeguarding people specifically at the Powell Community Center. It contains detailed operational information for each area within the Community Center. Once adopted, key highlights will be reformatted to be shared with the public.

Enhanced cleaning and sanitation protocols will be implemented at the Community Center. Employees will be required to wear masks at all times, and gloves where appropriate. Patrons accessing the fitness facilities either for workouts or rentals will be asked to wear masks while moving about the facility (though may be removed while exercising). Social distancing will be encouraged and enforced where appropriate.

The Community Center matrix is comprehensive, and several key recommendations are highlighted here:

- Restricted age guidelines during phases
- Exclusive access for vulnerable populations
- Cardio equipment spacing and use in Phase 2
- Selectorized 3quipment spacing and use in Phase 2
- Free weight use in Phase 3
- Pool use in Phase 3
- Rental group access anticipated to return no sooner than July 1

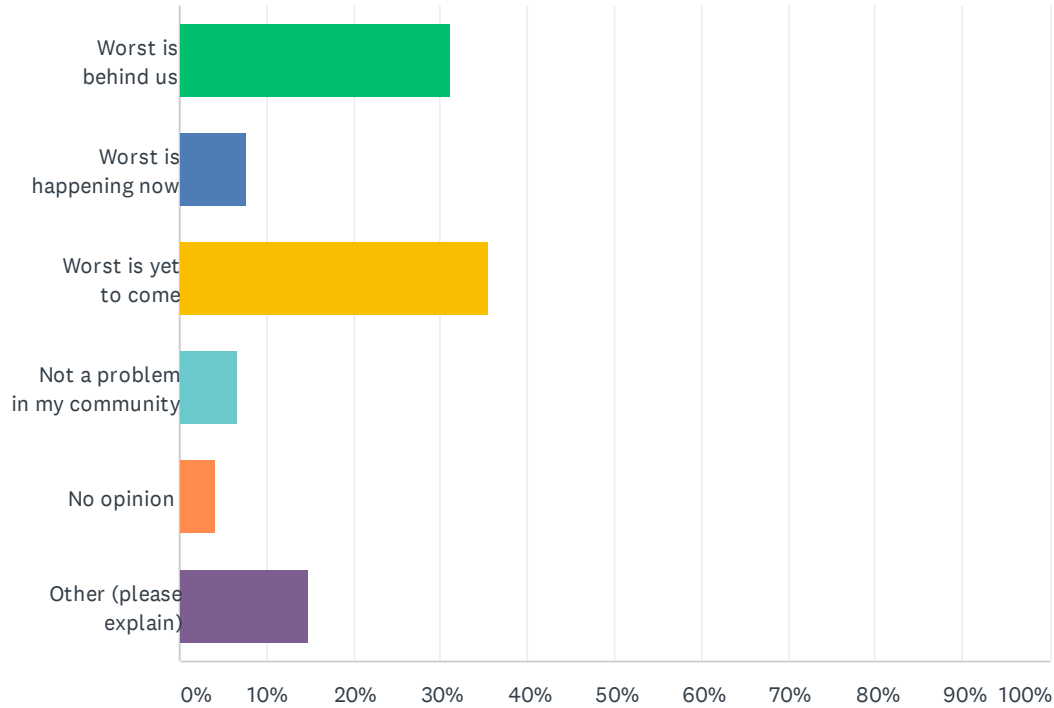

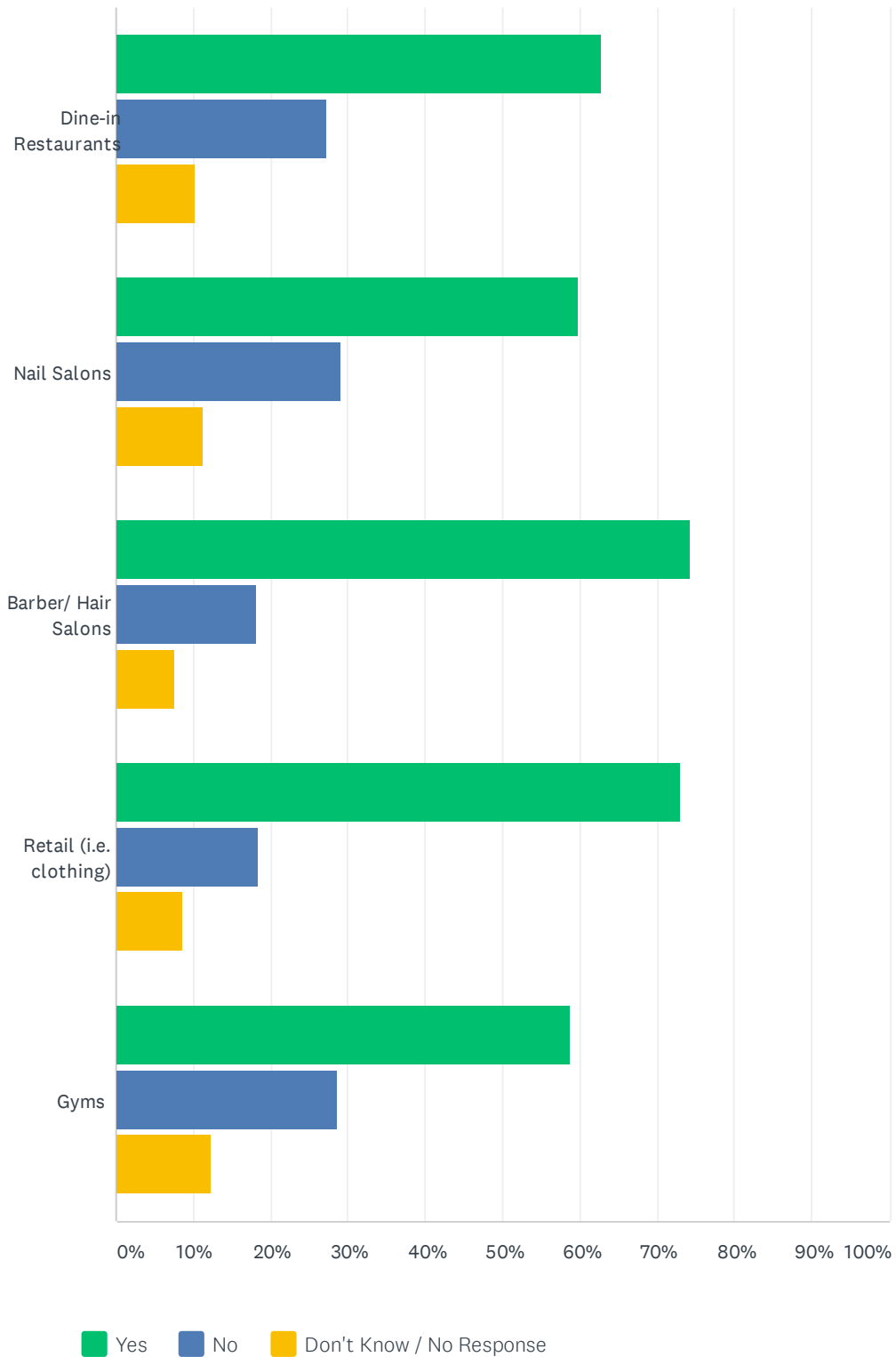

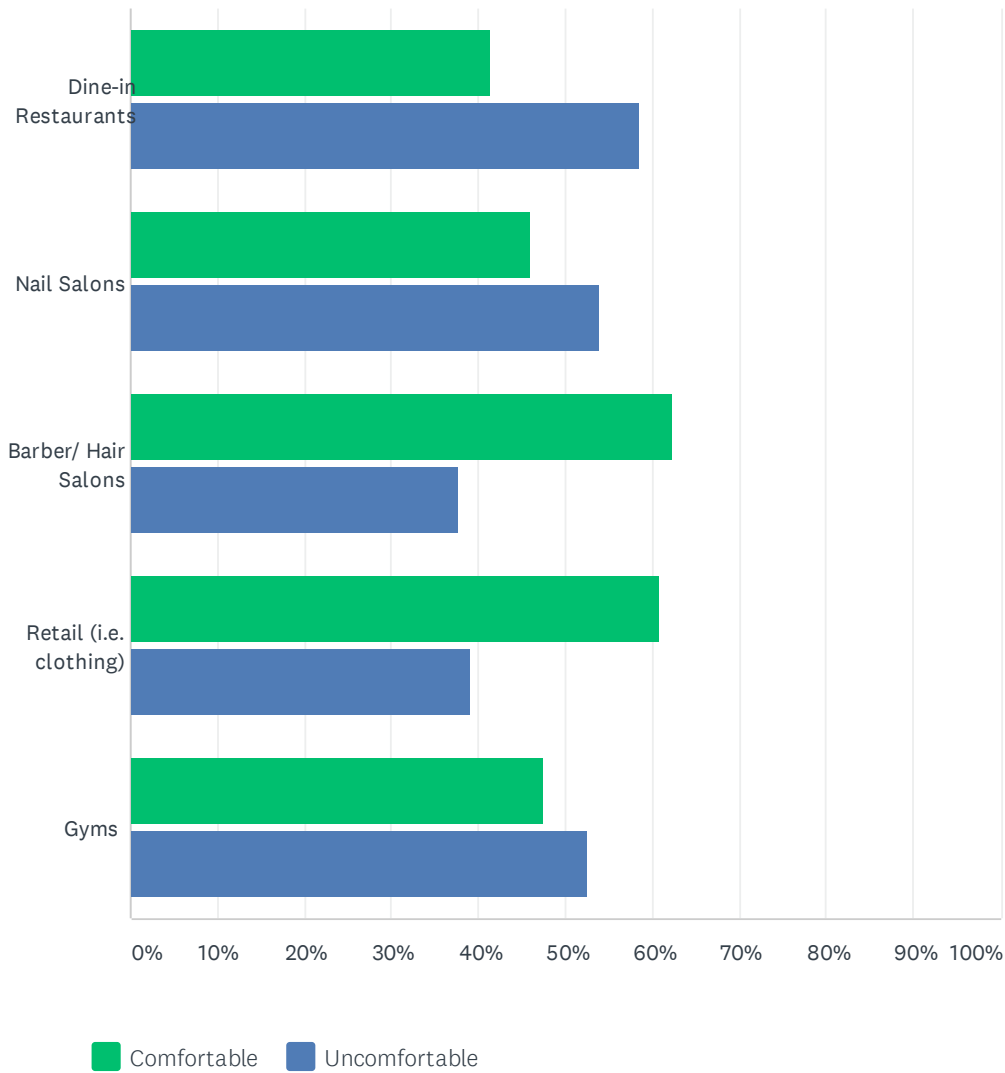

### Q3 Regardless of current restrictions, would you feel comfortable or uncomfortable at these locations at this time?

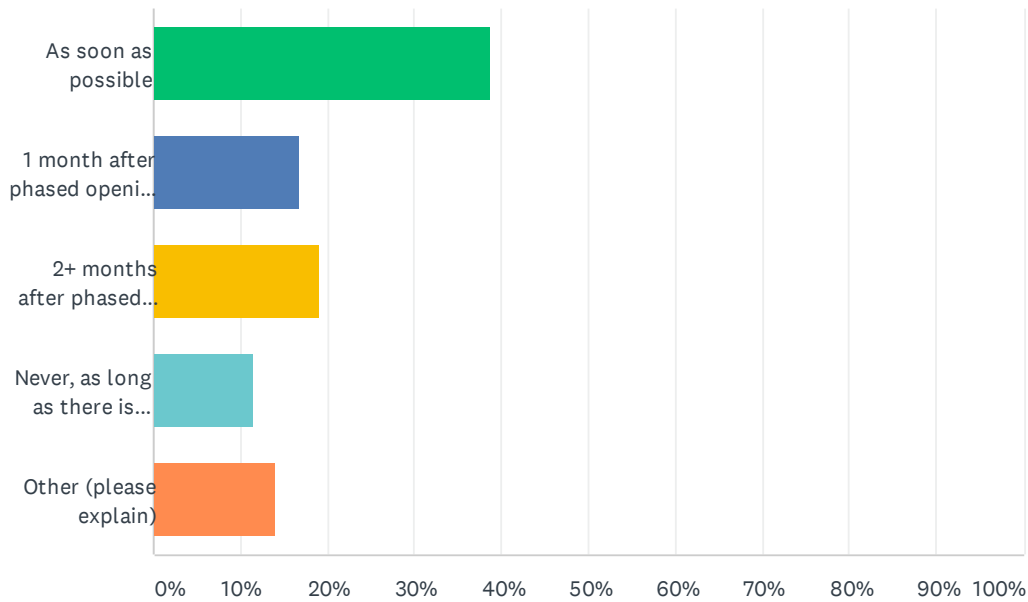

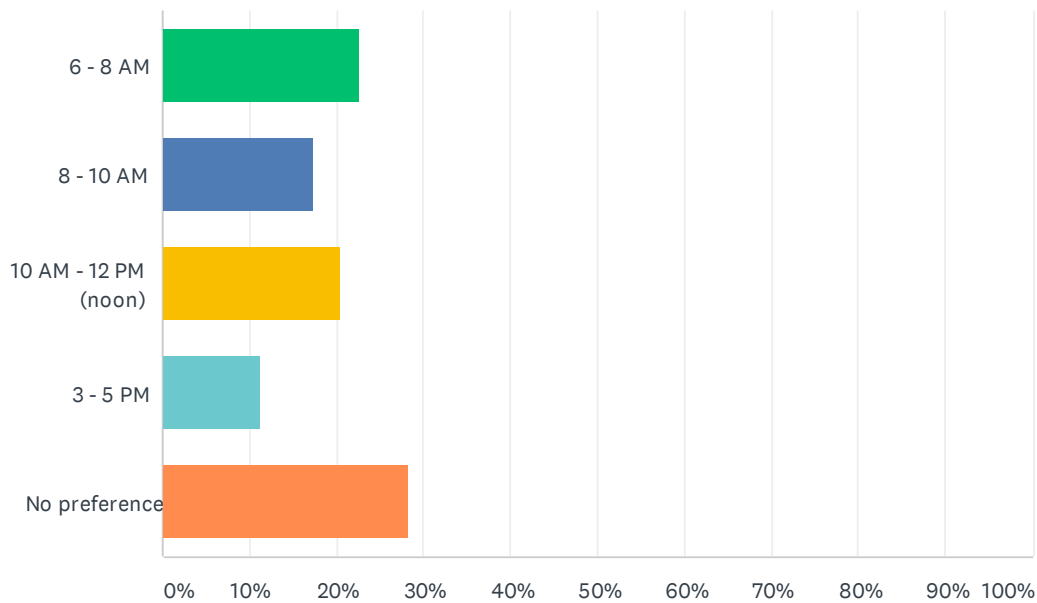

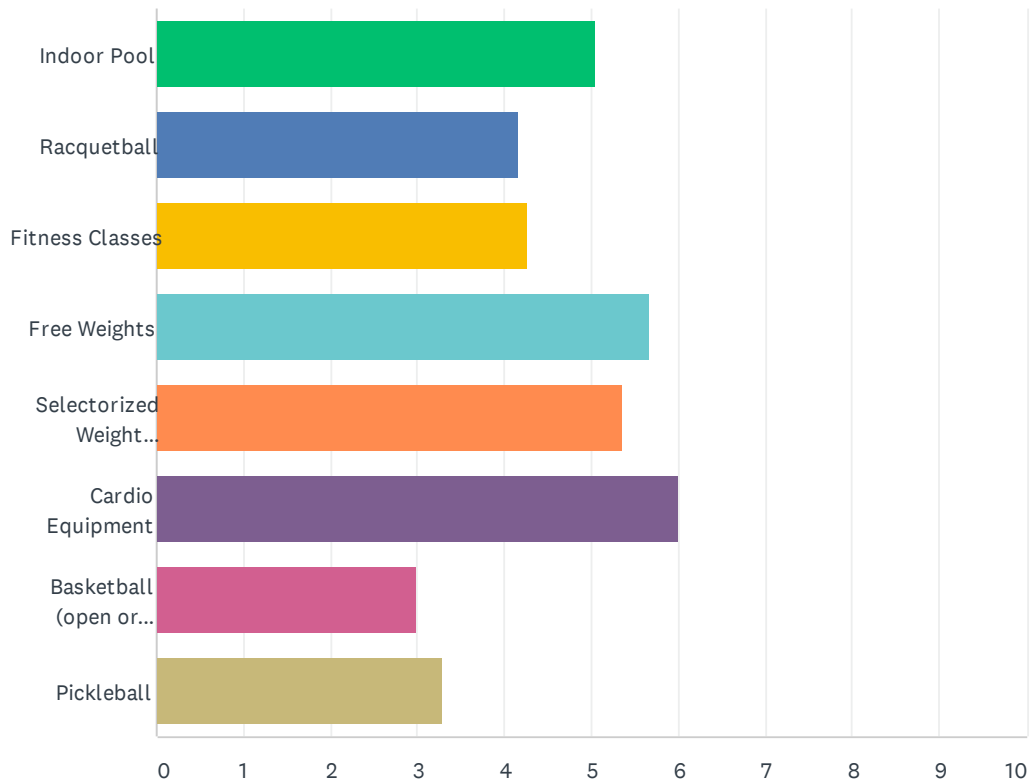

## Q6 Of the various fitness amenities offered, please order your preference for how amenities should be brought back on-line when phasing allows.

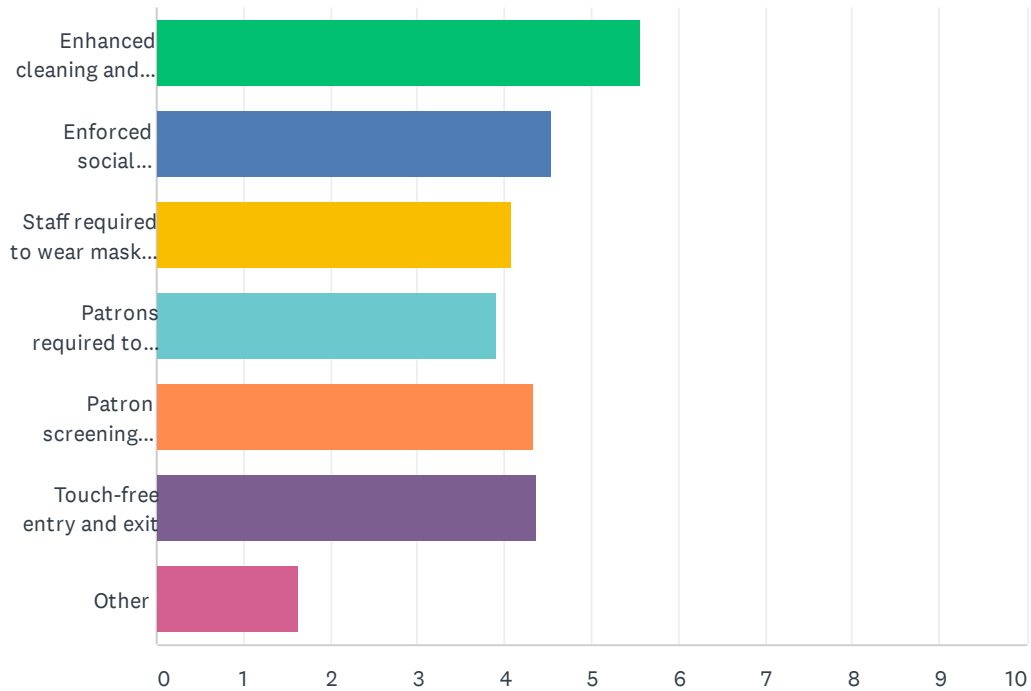
