RE: COVID-19 Protocols

RECOMMENDATION: Review and approve a reduction in COVID-19 mitigation strategies, protocols and procedures for the City of Mission

DETAILS: Throughout the COVID-19 pandemic Mission's Governing Body, staff and employees have thoughtfully and carefully implemented a variety of safety protocols designed to protect the health, safety and welfare of the public and our employees. These efforts have been undertaken in an effort to slow the spread of community transmission and to work to ensure that organizational staffing levels can be maintained to ensure continuity of operations.

In early January, following an upward trends in cases (percent positivity rates) in Johnson County and information from the Chief Medical Officers throughout the metro area about increasing demands on the hospitals and medical networks, COVID-19 protocols were increased throughout City facilities and operations. At that time a City mask ordinance was also put in place.

For the last several weeks, the incident rate/percent positivy rate for COVID-19 has continued to drop dramatically throughout the County. The City mask ordinance was allowed to expire on February 23, 2022 at which time the Council relaxed some, but not all of the COVID-19 protocols for City facilities. Since that time, the numbers have continued to decline and, as of March 22, 2022, Johnson County had a percent positivity rate of 2.6%, making this an area of low community transmission according to CDC guidelines.

However, although the current trends are encouraging, there is still the opportunity for a new variant to emerge which could negatively impact the number of cases and our healthcare systems and resources.

Based on the current data and public health recommendations, staff is recommending a removal of all current masking and distancing requirements throughout City facilities (for staff and patrons) effective Thursday, March 31, 2022. In order to remain as flexible and responsive to the pandemic as possible, the following considerations would be used to guide decisions should the data trend in a negative direction in the future. Staff believes it is important to establish some benchmark or threshhold against which to make future decisions in order to allow us to respond quickly and to know how to appropriately message this and any future changes to the public.
