RECYCLING TONS UP IN 2023

GFL MRF CONTAMINATION DROPS TWO PERCENT



Mission curbside volumes jumped to **614 tons** in 2023 from **517 tons** in 2022.

Contamination of overall inbound tons at the Harrisonville MRF fell and optical sorting upgrades improved the volume and marketability of recyclable materials.
