# **Quick Reference Guide**

## **Quiet Hours**

- Sunday-Thursday: 10:00 PM 7:00 AM
- Friday-Saturday: 11:00 PM 7:00 AM (8:00 AM on Sunday)

## **Key Rental Rules**

- Minimum stay: 2 consecutive nights
- Maximum occupancy: 2 adults per bedroom (10 people total maximum)
- No events, parties, or gatherings with non-registered guests
- Quiet enjoyment of the property only

## Parking Guidelines

- Use available street parking where permitted
- Don't block driveways or narrow streets
- No parking on grass (Section 425.100(B))
- No recreational vehicles
- Observe all posted parking signs
- Keep streets passable for emergency vehicles

## Waste Management

- Place all trash in secured containers to prevent litter
- Recycling is encouraged
- Store containers in garage or alongside house

# **Detailed Ordinance Information**

Short-Term Rental Regulations (Section 675.080)

The short-term rental of a dwelling or dwelling unit is subject to:

- Minimum rental period of two (2) consecutive nights
- Prohibition of use as reception space, party space, meeting space, or similar events open to non-occupant guests
- Occupancy limits of two (2) adults per bedroom with a maximum of ten (10) individuals total
- Compliance with all Disturbing the Peace regulations
- Compliance with all Nuisance Party regulations
- Adherence to all municipal codes and laws of the county and state

## Disturbing the Peace (Section 215.111)

#### It is unlawful to:

- Create excessive, unnecessary, unreasonable, or unusually loud noise
- Cause noise that annoys, disturbs, injures, or endangers others' comfort, repose, health, peace, or safety
- Operate any electronic device, radio, television, musical instrument, phonograph, or sound-producing device that disturbs neighboring inhabitants
- Create noise louder than necessary for convenient hearing by voluntary listeners in the same room
- Host gatherings that create disturbing volumes of sound
- Remain at a gathering causing a disturbance (except to help abate it)

## Police Officers may:

- Order immediate dispersal of groups creating disturbances
- Require owners/tenants to immediately abate disturbances

### Prima Facie Violations occur when noise is plainly audible at:

- Adjacent property lines
- 50+ feet away in multiple-family dwellings During these hours:
- 10:00 PM 7:00 AM Sunday night through Friday morning
- 11:00 PM 7:00 AM Friday night
- 11:00 PM 8:00 AM Saturday night

#### Nuisance Parties (Section 215.113)

A nuisance party occurs when a social gathering of five (5) or more people results in any of these activities at the site, on neighboring property, or on adjacent public streets:

- Unlawful sale, furnishing, possession, or consumption of alcoholic beverages
- Unlawful use or possession of marijuana or controlled substances
- Violations of peace disturbance regulations
- Assault and battery
- Property damage
- Littering
- Public urination or defecation
- Vehicle parking that blocks driveways or emergency vehicle access

- Conduct threatening injury to persons or property damage
- Trespassing on adjacent or adjoining property
- Indecent exposure
- Setting off fireworks
- Discharging firearms

## Being a Considerate Neighbor

#### Please be mindful of:

- Noise levels, especially outdoors
- · Car door sounds and vehicle alerts
- Music volume
- Outdoor conversation volume
- Neighbor privacy and property
- Proper parking placement
- Trash and recycling containment
- Local quiet hours
- Group size limitations
